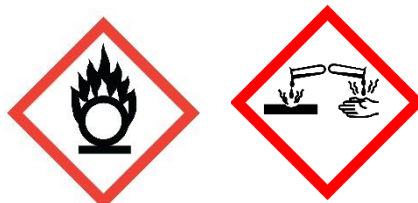

Section 5: Fire-fighting measures

Specific hazards: In an ambient fire, nitrous gases (nitric oxides), hydrogen chloride, carbon monoxide and carbon dioxide and metal oxide fume can be released.

Special protective equipment: Wear self-contained breathing apparatus and special tightly sealed suit.

Section 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures: Particular danger of slipping on leaked/spilled product. Wear protective clothing (See section 8). Keep unprotected persons away. When selecting the protective suit, attention has to be paid to the complete and safe protection of skin and mucous membranes. Impermeable protective clothes, protective boots must be made of neoprene, complete face protection and nitrile-rubber gloves with long tops should be worn.

Environmental precautions: P390 Absorb spillage to prevent material-damage. As the undiluted product is hazardous for the aquatic environment, it must be prevented from reaching surface water. Prevent from spreading (e.g. by enclosing with a ring of chemical absorbent). Inform authorities in case of contamination of water or sewage system.

Methods and material for containment and cleaning up: Collect large amounts in suitable container. Cover the rest with absorbent, mix intensively and collect mechanically.

Section 7: Handling and storage

Precautions for safe handling: Provide good room ventilation or local exhaust ventilation at the workplace. Product to be diluted with cold water to prevent bacterial growth.

Requirements to be met by storerooms and containers: P405 Store locked up. Ensure sufficient ventilation. Store only in the original container. Protect from sunlight and do not expose to temperatures exceeding 50°C. Fill only into labelled containers and do not leave the container open.

Special precautions for user:

- Oxidizing substance. Keep away from combustible material, from reducing agents, from ammonium compounds and from any source of heat. Do not load with Class 3 flammable liquids, Class 4 substances or organic peroxides.
- Contact with acids liberates toxic gas (EUH031). Do not load with Class 8 acids in the same load compartment, and keep separated from them in stowage at sea.
- Risk of explosion if heated under confinement (EUH044). Keep packages dry, out of direct sunlight and below 50 °C. Note that Section 9 of this document records "Danger of explosion: Not applicable", which contradicts the EUH044 statement in Section 2; the two must be reconciled.
